 ^On 19 and 26 August 2025, the measured noise levels of NM2b exceeded the limit level of 70dB(A). However, they were lower than the baseline level of 73.4 dB(A). Therefore, they are not considered as an limit level exceedance.
 # The noise monitoring originally scheduled for 05 August was rescheduled to 07 August due to unfavorable weather.
 # The measured noise levels exceeded the noise level of 70dB(A) and they were higher than the baseline level of 73.4 dB(A) for NM2b & 69.8dB(A) for NM3.
 Therefore, baseline corrections were carried out and the corrected noise level which solely represent the noise level of Construction works are lower than the noise criteria. As such the EAP was not triggered.
